2. Training period will commence from the date you are enrolled. It must be clearly understood that although effort will be made to absorb you in the regular cadre of this Railway, if there is any vacancy after your successful completion of the period of training but no such grantee is given therein.

3. If at any time during the training period both at the training school as well as in the Division your services do not satisfy your superior authorities that you are not making good progress, you may be discharged from the traineeship.

4.
